Dear Sir,

We are instructed by The Anheuser-Busch Brewing
Association of St. Louis to call your attention to the labels
under which your Export Beer is being sold. In our clients'
opinion this label is such that it cannot but have been used for
the purpose of deceiving purchasers into the idea that they are
obtaining our client's Budweiser Beer, and we have evidence that
it is actually being supplied to purchasers who ask for Budweiser.
We are inclined to commence proceedings against you for
damages and an injunction, but it occurs to us that these pro-
ceedings may not be necessary, and we should be glad to hear
from you as to what you are willing to abandon the use of
these labels, destroy any stock of them you may have on hand,
together with the labels prepared for them, and pay our clients a
reasonable amount to cover the loss which the use of them has
already caused.

If you are willing to meet us along these lines kindly let
us hear from you no later than the 25th inst.
