- (a). On the grounds set out in the Respondent's particulars above stated.
- (b), That the alleged accident to the deceased workman was attributive solely to his serious and wilful negligence.
 - (c). That the deceased left no dependants.
- (d). That the parties on whose behalf arbitration is requested herein are not the dependants of the deceased.
- 4. The Respondent intends at the hearing of the arbitration to give evidence and rely on the following facts:-
- (a). That no notice of the alleged accident to the deceased was given to the Respondent as required by Section 4 of the Workmen's Compensation Act. 1908.
- (b). That no sufficient notice of the alleged accident was given to the Respondent as required by the said Act.
- (c). That any notice given under the said Act was not given within the time required by the Act.
- (d). That no claim for compensation was made upon the Respondent as required by the said Act or within the meaning thereof.
