TO WIT:

I, *James Peter Mitchell* a *Notary Public*

do certify that *Frederick George Herder* an alien, on the *Twelfth*  
day of *November* 1888, subscribed and took, before me the oaths authorized by the eighth section of "The  
Naturalization Act," and therein swore to a residence in Canada of *14* — years; that I have reason to believe  
and do believe, that the said *Frederick George Herder* within the period of *14* — years  
preceding the said day, has been a resident within Canada for three years, that the said *Frederick George Herder*  
is a person of good character, and that there exists, to my knowledge, no reason why the said *Frederick*  
*George Herder* should not be granted all the rights and capacities of a natural-born British subject.

do sincerely promise and swear that I will be faithful and bear true allegiance to Her Majesty Queen Victoria, as lawful Sovereign of Great Britain and Ireland, and of the Dominion of Canada, dependent on and belonging to the said Kingdom, and that I will defend Her to the utmost of my power against all traitorous conspiracies or attempts whatever which shall be made against Her Person, Crown and Dignity, and that I will do my utmost endeavor to disclose and make known to Her Majesty, Her Heirs or Successors, all treasons or traitorous conspiracies and attempts which I shall know to be against Her or any of them; and all this I do swear without any equivocation, mental evasion or secret reservation. So help me God.
