3. Frank Ruzek, is not at the present active in Red movements, but I understand his leanings are more in that direction than they should be.
4. Vince Gurjel, is very Red, I am advised on good authority.
5. Anton Pomahac, is a member of the M.W. Union of Canada, and an ardent supporter of anything Communistic.
6. W.E. Ostrensky, has been reported on previously, at present is not active in Communist circles, but was formerly an organizer for the Young Communist League.
7. Matej Kral, is a member of the Communist party, and is very active in the Young Communist League.
8. George Riapos, is a Slav, and from my enquiries has no Red tendencies.
9. Antone Zur has no Red Leanings at all.
10. I have been unable to the present to obtain any information regarding the activities of the men Horejsi or Adamac.
